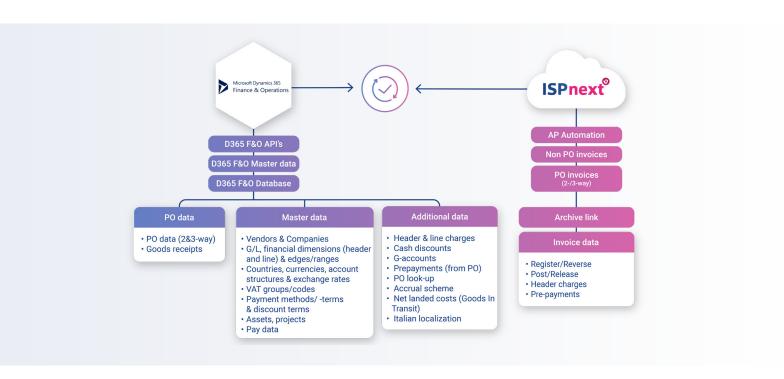

Real-time data exchange

Our integration uses D365 Finance & Operations' APIs for real-time data exchange. This keeps datasets consistent and up-to-date, which is crucial for effective administration.

- Master data: Synchronisation of suppliers, financial dimensions, countries, currencies, payment methods and assets.
- PO data: Processing of sales orders (2-way and 3-way matching) and goods receipts.
- **Specific data:** Support for accrual schemes, discounts, G-accounts and prepayments, including regional adjustments.

AP Automation

With our solution, you streamline the entire invoice processing process (AP Automation). Both PO invoices (2-way and 3-way matching) and non-PO invoices are processed efficiently and linked to an archive system. This gives you more control over outstanding liabilities and prevents errors such as double payments.
